Public Comment: John Kroll addressed the board asking about the Township Blight Ordinance, comments were made stating the board should be responsible for all blight issues in the township and Mr. Kroll feels the board is not doing their job. Supervisor Jensen explained the Blight Ordinance procedures to Mr. Kroll and stated if Mr. Kroll wanted to sign a Blight Complaint all procedures would be followed. Mr. Kroll asked about a residence in Oak Park that appears to be a blight issue, Supervisor Jensen explained that if Mr. Kroll wanted to sign a blight complaint he (Supervisor Jensen) would stay after the meeting for as long as necessary.

David Berndt addressed the Board regarding Blight issues in Wells, there are two houses that are in very poor condition, and Mr. Berndt asked about the resident that is continuing to have fill hauled to his property. Supervisor Jensen stated he spoke to Mr. Sabor (county) and the Eaton house was put up for up for auction with \$20K in the bid for demo; there weren't any bidders, therefore the house will be put up for auction a second time with the \$20K for demo in the bid price, if there aren't any successful bidders at the second auction the county will demo the house from funds they have budgeted for this type of thing.

The other residence would need to have a blight complaint signed, Mr. Berndt stated he would stop by the office tomorrow (Thursday – October 19, 2017) to sign the complaint. Regarding the residence with the fill Supervisor Jensen stated he would be calling Rory Mattson to see if anything can be done.

Board Comments Trustee Johnson asked about the Sampson residence – Supervisor Jensen stated the property is zoned residential and the DEQ had been to the residence however they didn't find anything that was considered a Hazmat issue. Supervisor Jensen stated the owner is not in compliance with the last court order and the issue is being addressed.

Trustee Johnson stated she was called by a resident regarding the Tot Lot and broken equipment Supervisor Jensen stated he called Tiny Tykes Corporate office a couple of times and has not been able to get any response.
